10.c. Peer Review on Energy Efficiency (PREE)

PREE consists of two pillars:

- **PREE** to provide recommendations for the host economy on how implementation of their energy efficiency action plans could be improved, and **Follow-up PREE** to help a previous PREE host economy to more smoothly implement recommendations on energy efficiency action plans;
- **Energy Efficiency Policy (EEP) Workshop** to further discuss key issues in policy formation for energy efficiency.

Phase 7:

1. Follow-up PREE

- **Follow-up PREE in Malaysia** was conducted on 26-30 March 2018 in Putrajaya, Malaysia.

2. Energy Efficiency Policy (EEP) Workshop

- **The 3rd EEP Workshop** was held in Washington, D.C., USA on 10 April 2018 in conjunction with EGEEC 51.
- The topic was **conformity assessment**.

10.c. (3) Follow-Up PREE in Malaysia

- **3 days of workshop, 1 day of site visit and 1 day of recommendations preparation and presentation to Government.**
- **Malaysia is in the process of drafting the Energy Efficiency and Conservation Act and launched the Green Technology Master Plan in July 2017 to escalate the low carbon technology deployment.**
- **The challenges and recommendations were divided into three categories**
 - **Overarching**
 - **Land transportation**
 - **Thermal energy use in industry**
- **Details will be reported at EWG56.**

10.c. (4) Energy Efficiency Policy Workshop

- **29 representatives from 11 economies attended.**
- **Focused on conformity assessment, which is the process of ensuring that a product or service meets the standards, regulations or specifications that it is designed or advertised to do.**
- **Delivered by CLASP, a not-for-profit, with presentations by invited experts from Malaysia, Mexico, New Zealand and the US.**
- **Included a panel and group discussion sessions.**
- **Summary report will be circulated when it's ready.**
- **Currently seeking new proposals and feedback for the next workshop to be held in the first half of 2019 with EGEEC 53.**



10.c. (5) Future Plan of PREE

- **Plans after the approval of Budget:**
 - **PREE Phase 8: the 12th PREE in Russia and the 4th EEP Workshop to be held with EGEEC 53 (Concept Note was submitted to the project S1, 2018)**
 - **PREE Phase 9: the 5th Follow-up PREE in Peru (Concept Note was submitted to the project S2, 2018)**
